Certified Community Behavioral Health Clinics (CCBHCs) to Continue in Florida Thanks to Partnership

Orlando, Fla. – Simply Healthcare Plans (Simply) presented the Florida Behavioral Health Association (FBHA) a grant for \$150,000 for Certified Community Behavioral Health Clinics (CCBHCs) in Orlando on Thursday, August 18.

The CCBHC model is an innovative, integrated healthcare model developed to ensure access to coordinated comprehensive behavioral health care. CCBHCs serve anyone who needs care for mental health or substance use disorders, regardless of their ability to pay, where they live, or their age.

Currently, FBHA members operate 12 of the 13 CCBHC grants in Florida, according to Brown-Woofter, and are seeing resounding success. CCBHC patients in Florida have experienced a 69% decrease in hospitalizations for a mental health condition and a 92% decrease in incarcerations.
