

MESSAGE FROM THE PRESIDENT

Members, thank you for another amazing year. Our accomplishments in 2022-23 strengthen our collective ability to reach individuals and families that are dealing with mental health illness and substance use disorders, build stronger families and grow resilient communities.

This legislative session concluded with historic funding and policy direction for community behavioral health, both big wins. We were successful in getting rate increases for Medicaid and for treatment programs for individuals leaving incarceration. The Legislature fully funded Florida's central receiving facilities with recurring general revenue – an undeniable acknowledgement that it is a fundamental component of Florida's behavioral health system. In addition, the Legislature directed the first step toward Florida becoming a CCBHC state. These accomplishments signal a clear and strong endorsement of the importance of your work.

Florida Behavioral Health Association staff continued to advocate for policy changes that remove barriers to effective operations. We kept you informed and solicited your input through weekly membership calls, in-person board meetings, and division and workgroup forums. We also continued to engage new stakeholders that foster greater collaboration and partnerships. Challenges remain – we continue to face extreme workforce shortages, but we are committed to realizing immediate and long-term solutions.

This annual report showcases your passion and hard work. You inspire us, and we are honored to work alongside you. Thank you for everything you do to make a difference in the lives of Floridians.

ADVOCACY

FBHA enjoyed some **really big wins** during the 2023 Legislative Session! FBHA members made out exceptionally well on the appropriations funding side of the political process. While the session might be considered "policy light" by some, the budget wins also represent a strong endorsement for the importance of Florida's behavioral health system.

The total 2023-24 budget was **historic** for behavioral health, spending over \$117 billion on programs, services, initiatives, and infrastructure across Florida. This spending plan came in at 7% above the 2022 budget.

COMMUNITY BEHAVIORAL HEALTH WINS

- Behavioral health Medicaid rate increase of \$29.7 Million or a 15% increase to select services in the community behavioral health fee schedule.
- Recurring funding increase to central receiving facilities totaling \$51 Million.
- **Direction to the state** to request federal approval for Medicaid coverage of the certified community behavioral health centers.
- 15% rate increase within the Department of Corrections in the community setting for behavioral health services.
- Total investment of \$96 Million in non-recurring FBHA member special projects.
- O Investment in community behavioral health infrastructure capital outlay in the amount of \$59.6 Million.


