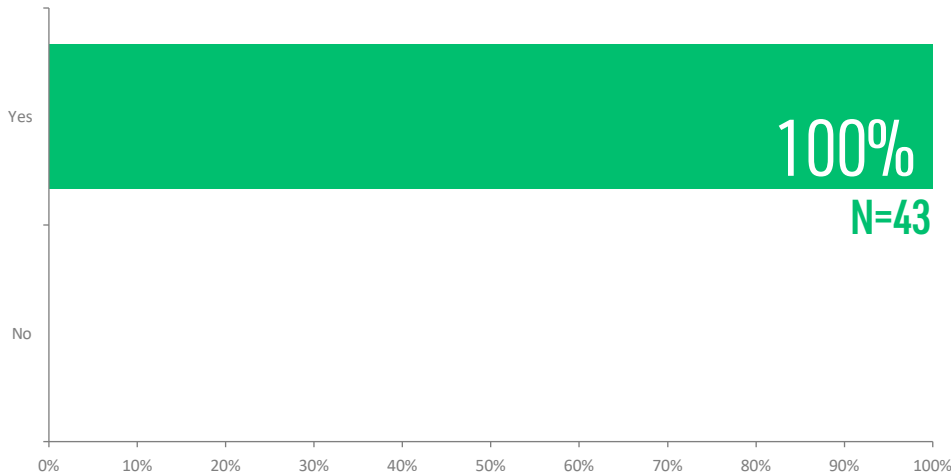

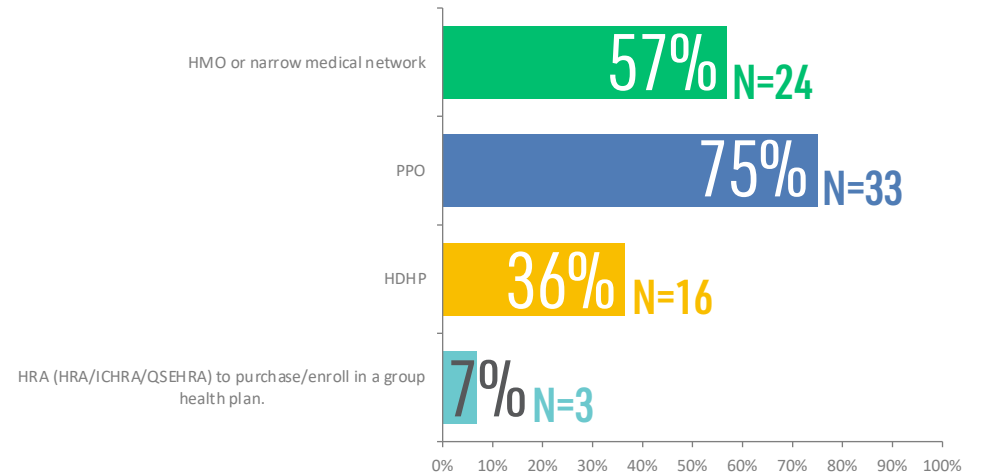
## Does your organization offer health insurance to your employees?

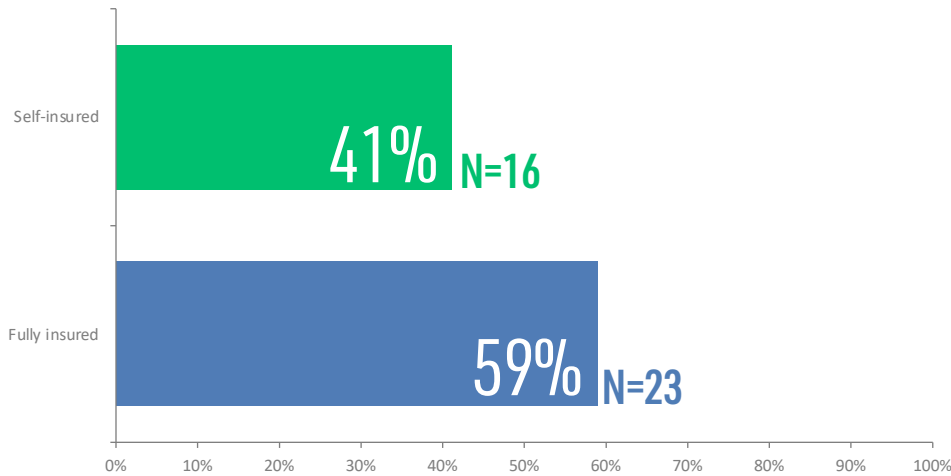

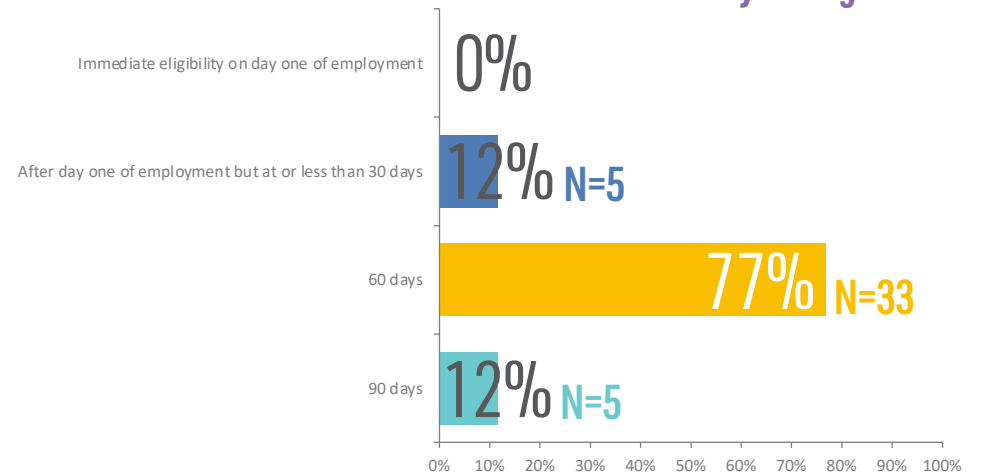

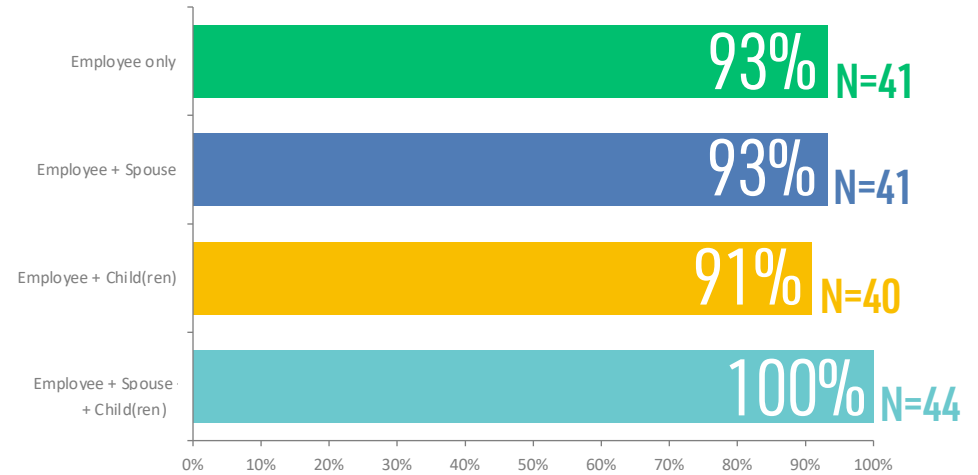

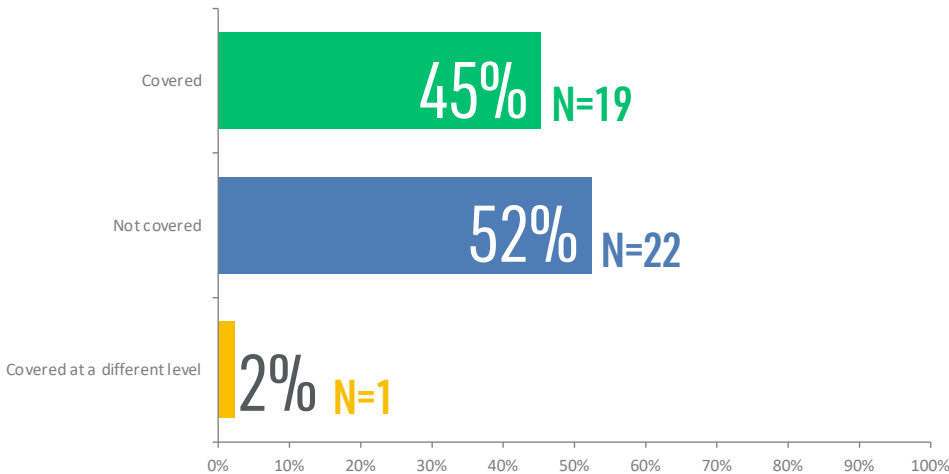

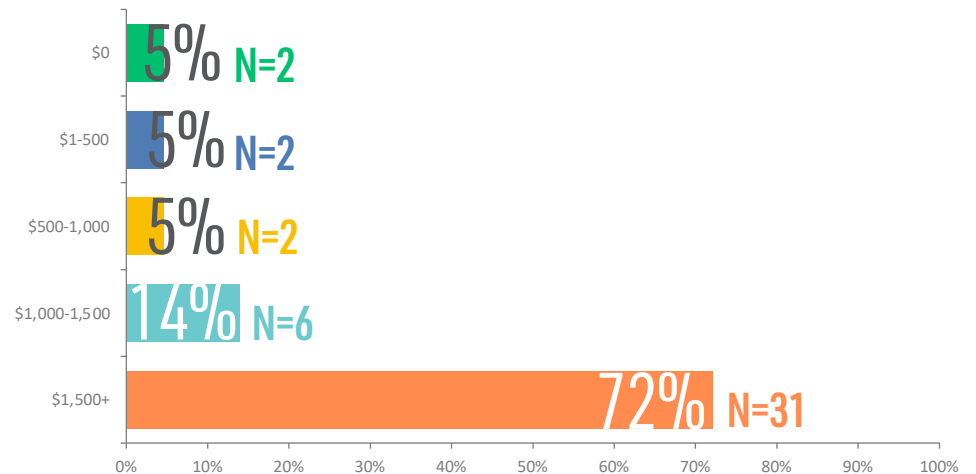

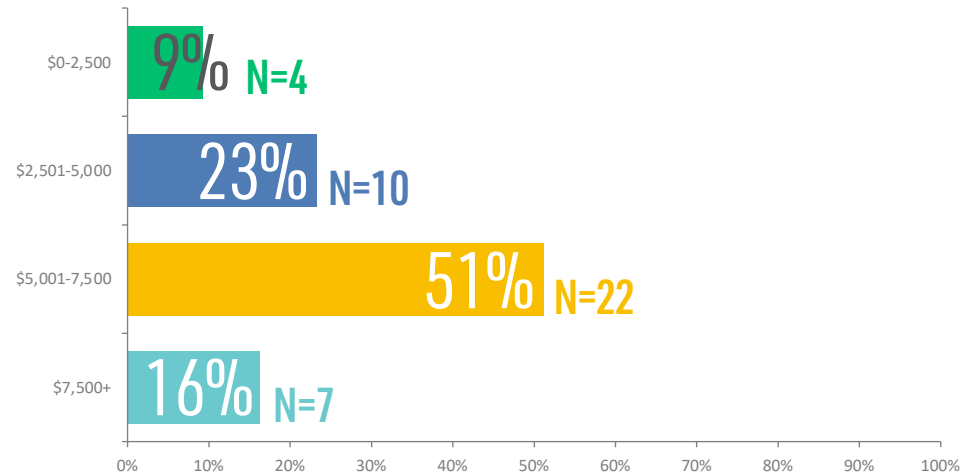
## Family deductible in-network

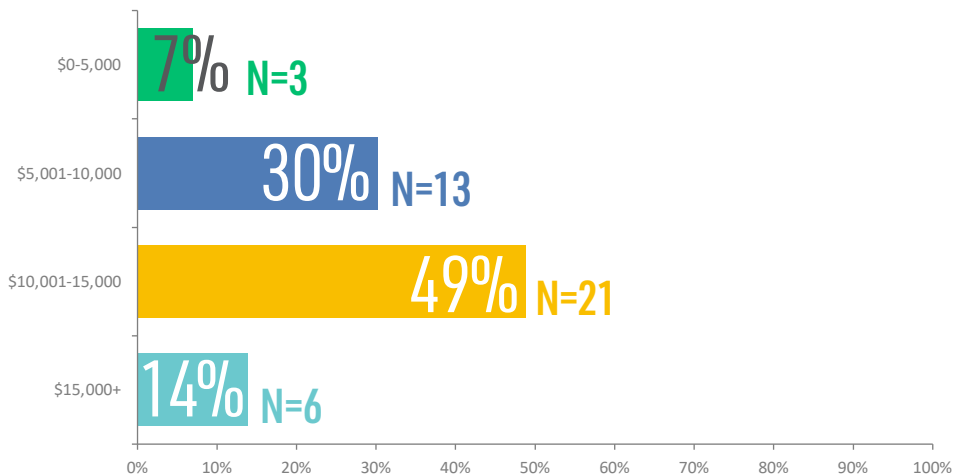
## Single covered member maximum out-of-pocket in-network

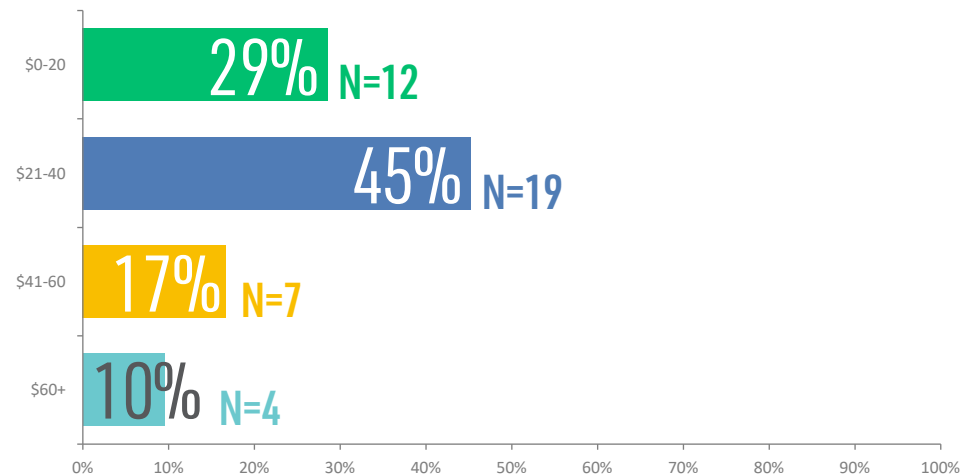

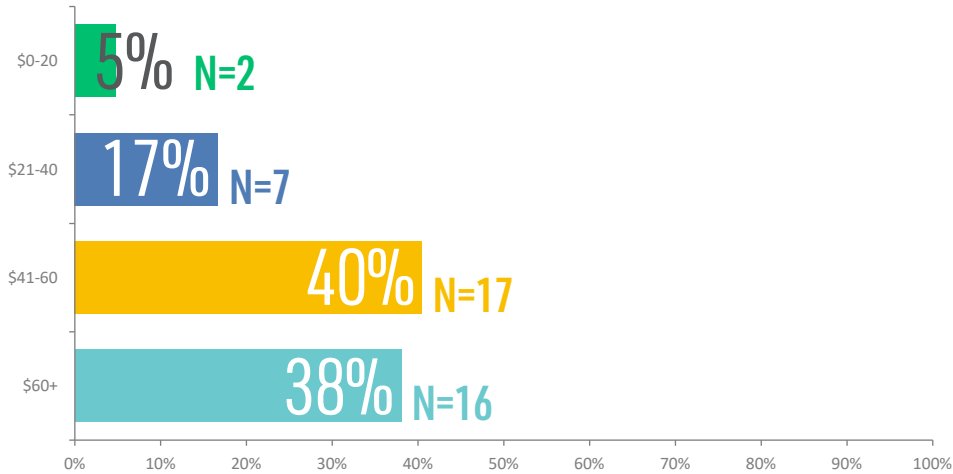

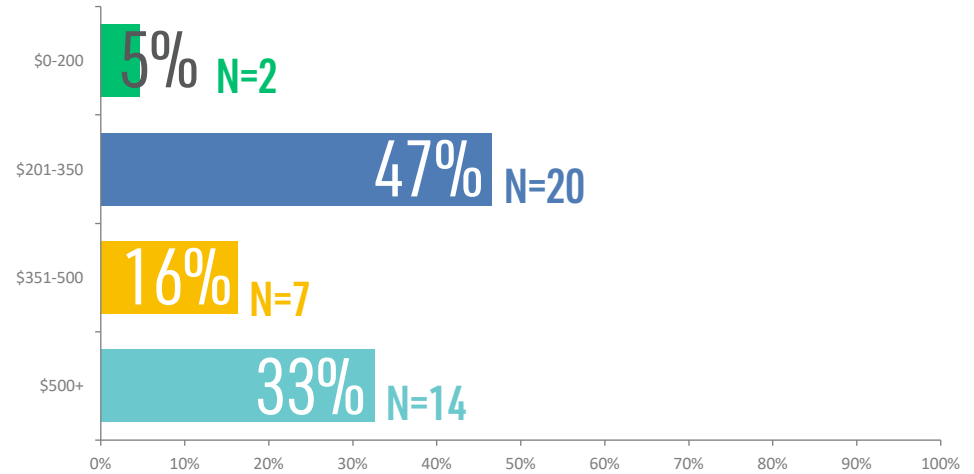

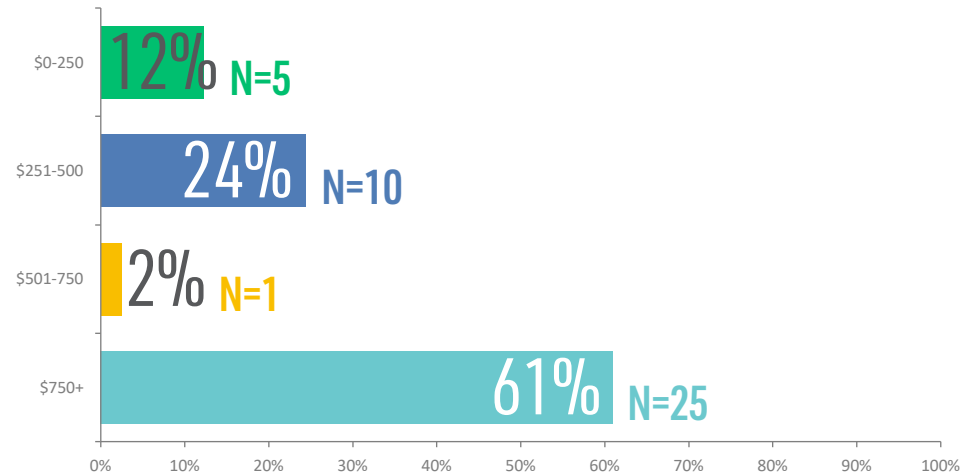

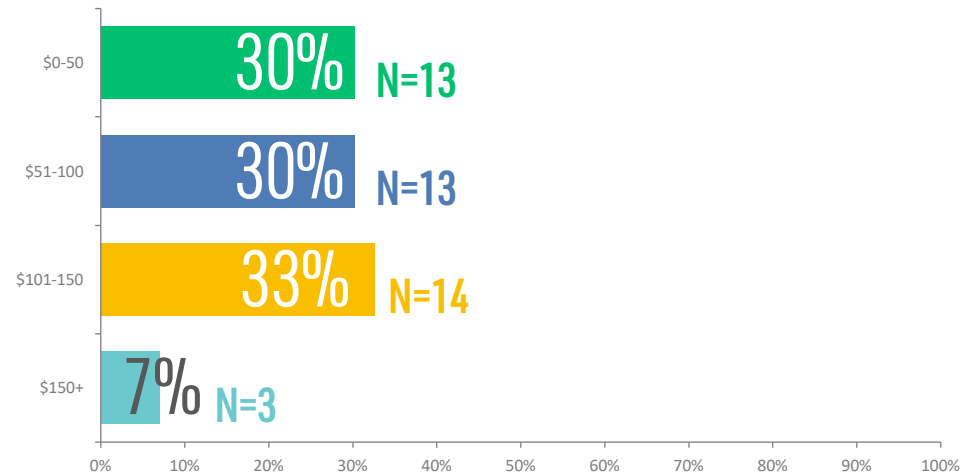

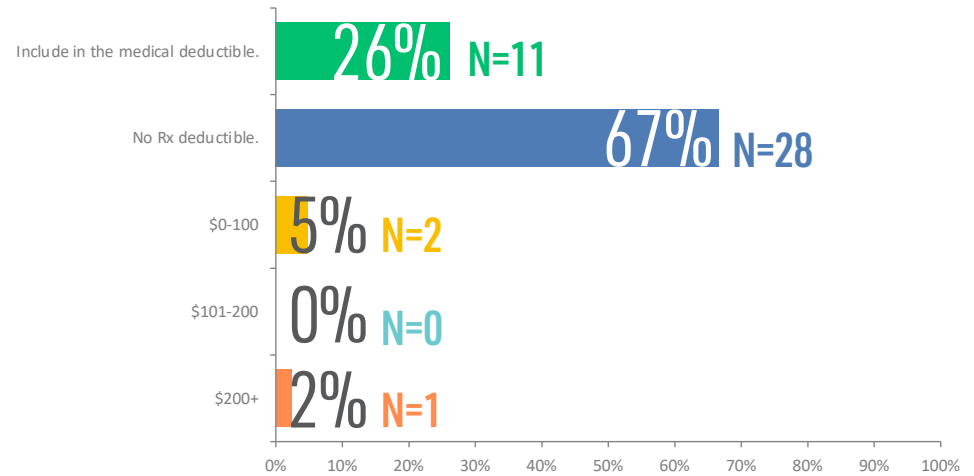

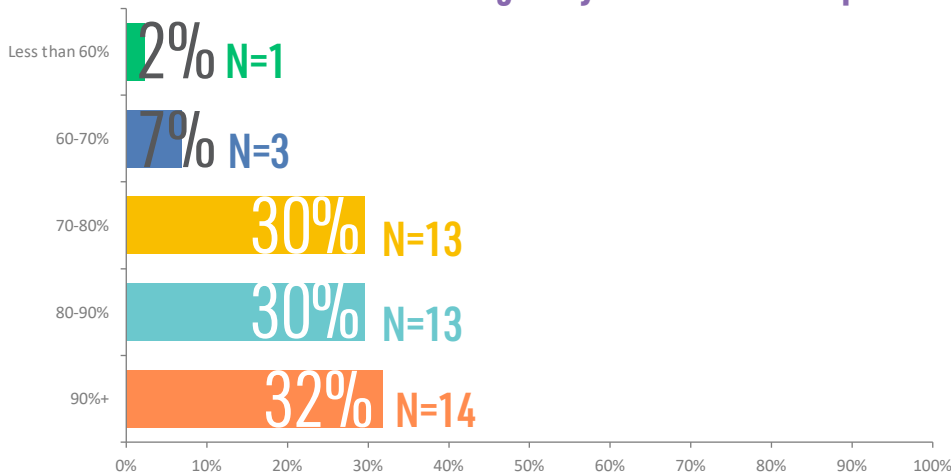

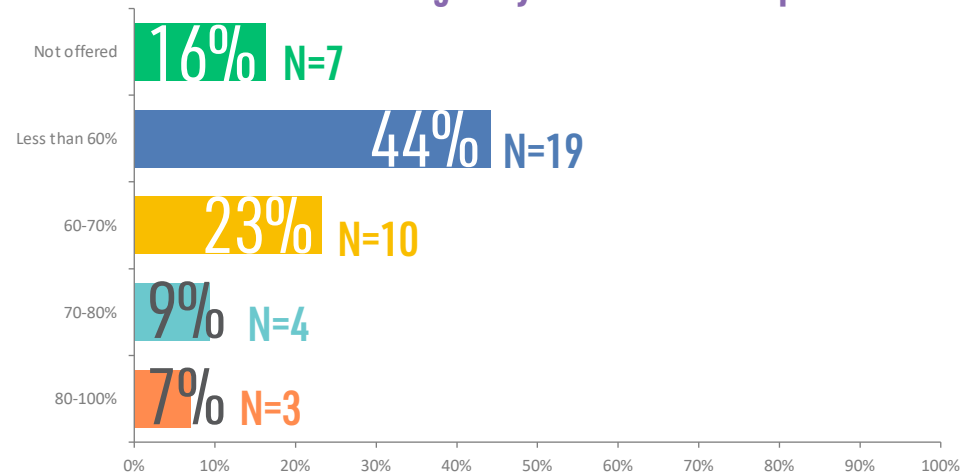

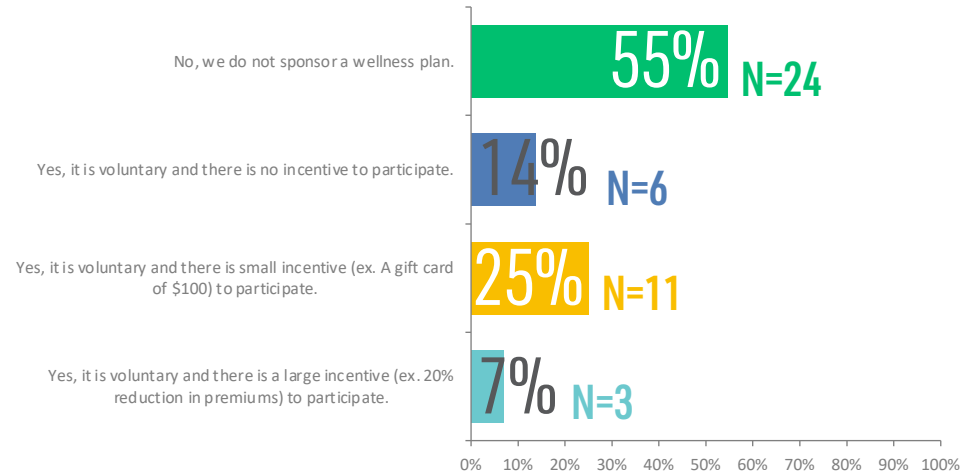

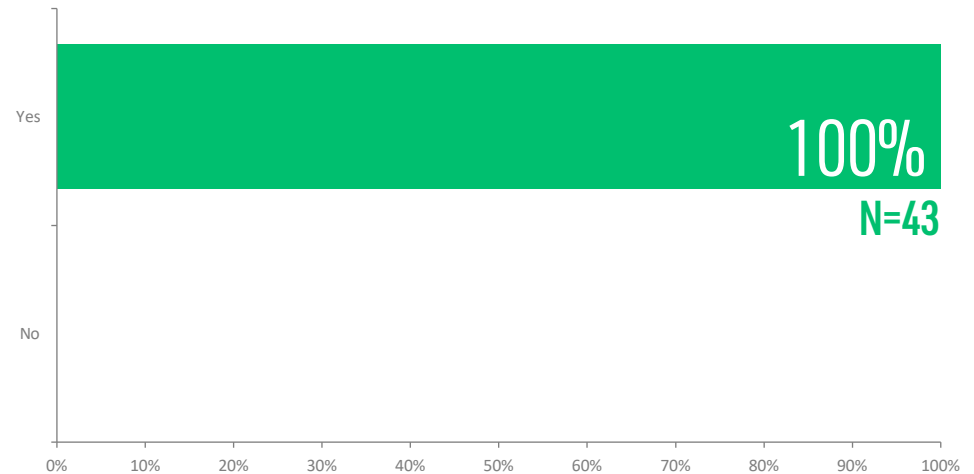

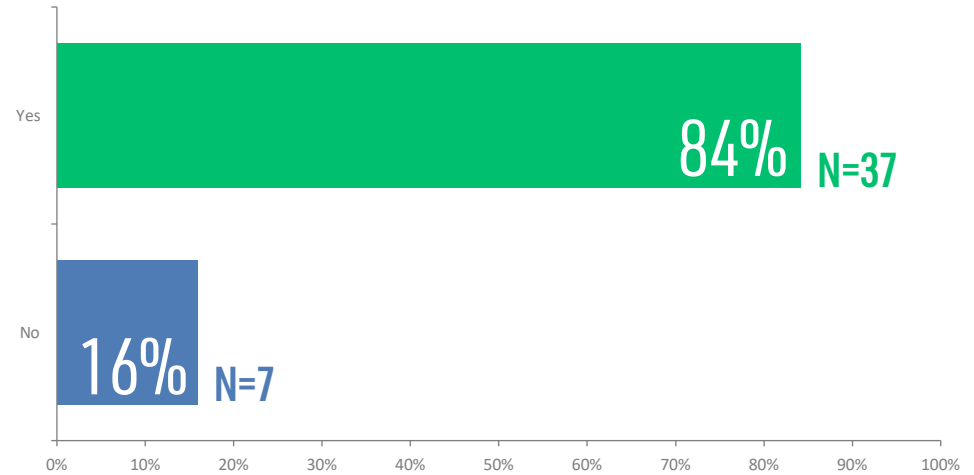

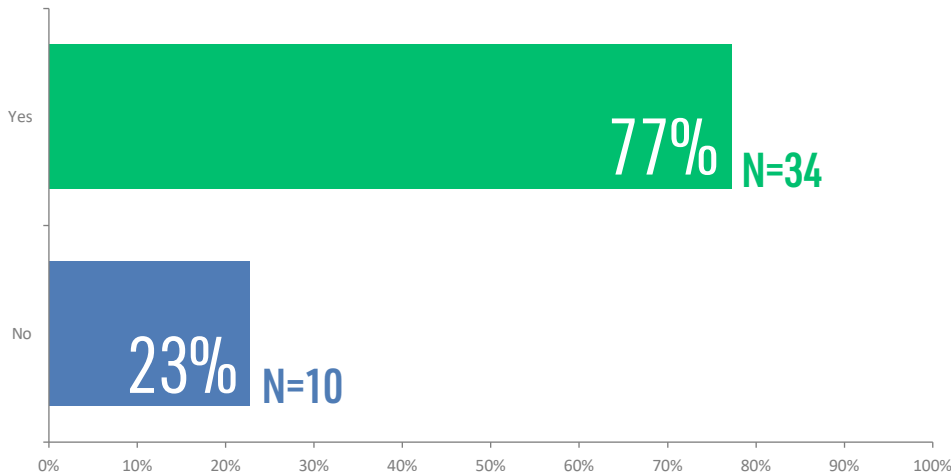

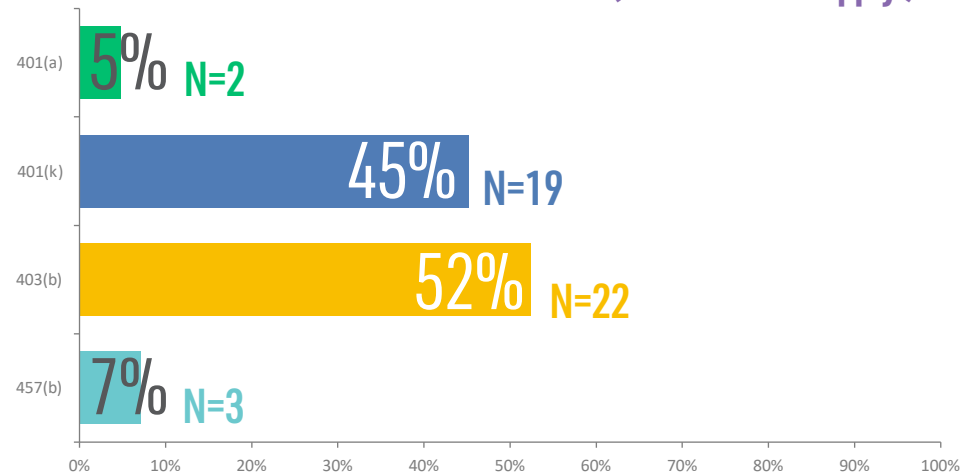

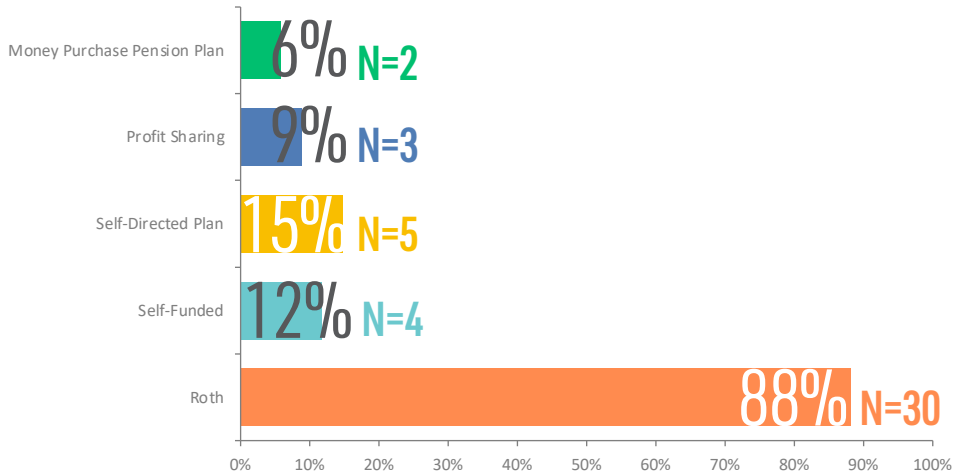

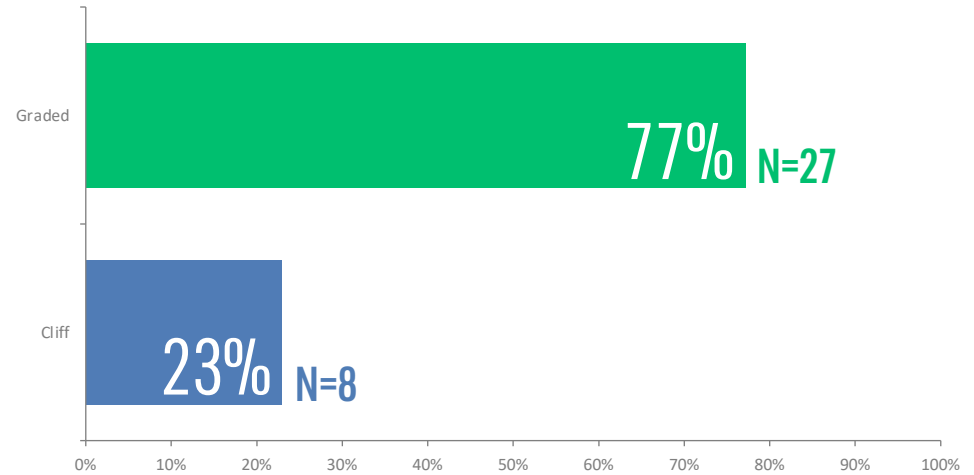
